WRITTEN NOTICE FOR A SPECIAL MEETING OF REPUBLICAN GOP CAMPBELL COUNTY, KENTUCKY COMMITTEE TO BE HELD ON JULY 29, 2014, 6:30 PM AT 1073 INDUSTRIAL ROAD, COLD SPRING, KENTUCKY 41076.

THE PURPOSE OF THE MEETING IS TO TAKE A VOTE TO DISMISS JEFF KIDWELL AS PRESIDENT OF THE CAMPBELL COUNTY, KENTUCKY REPUBLICAN GOP COMMITTEE. AND TO FURTHER TAKE A VOTE TO DISMISS THE OTHER SAID COMMITTEE OFFICERS NAMELY WINI STINE VICE PRESIDENT, PETE GARRETT SECRETARY, DAVID MARTIN AND OR JAY DICKERSON TREASURY, ELIZABETH KIDWELL YOUTH CHAIRMAN. KEVIN SELL, TONY ROUSE, AMY TOWLES, ASHLEY WOODS (all listed as officers on CCGOP Web Site 06/18/2014). FURTHER IF ANY SAID COMMITTEE OFFICERS ARE DISMISSED TO TAKE NOMINATIONS AND A VOTE TO FILL ANY AND ALL VACANCIES.

We the undersigned members of the Campbell County Kentucky GOP Precinct Leaders and Committee Members, pursuant to the RPK rules, call a special meeting of said committee to remove the committee to vote yay or nay to remove Jeff Kidwell as president for being guilty of malfeasance, nonfeasance, and misfeasance, as specified below. Also to dismiss any or all of the other said committee officers namely Wini Stine Vice President, Pete Garrett Secretary, David Martin and or Jay Dickerson Treasury, Elizabeth Kidwell Youth Chairman. KEVIN SELL, TONY ROUSE, AMY TOWLES, ASHLEY WOODS (all listed as officers on CCGOP Web Site 06/18/2014). For acting in concert with or giving tacit approval to the actions of the President Jeff Kidwell. Further if there is an affirmative vote to remove other officers to immediately call for nominations and a vote to fill any vacancies.

The facts to establish the malfeasance, nonfeasance, and misfeasance are:

1. Failing and refusing to call any county committee meetings.
2. Calling secret meetings of an, "executive committee" which was never voted on.

3. Failing and refusing to give notice of any type of meeting stating that his e-mail does not work.
4. Bring the Republican Party into disrepute when at the 2012 re-organization he placed a red star by the names of good and loyal republicans who he did not like and refused to allow them to participate in the re-organization.
5. He failed to reserve a booth for the County Fair in 2012. The first time in over 100 years. He then cursed members of the Fair Board for his failure to timely file for a permit.
6. He appointed himself to fill the vacancy as the sheriff candidate in 2012 even though a number of more qualified candidates applied.
7. He diverted \$10,000.00 dollars from the Campbell County Treasury to his 2012 Sheriff Campaign.
8. He failed and refused to give funds from the Treasury to any of the other 2012 candidates.
9. He has brought the Republican Party disrepute by using his Presidency to further his political ambitions.
10. He has alienated current and prospective Republicans by not holding regular meetings.
11. As sheriff he practiced nepotism by giving the best jobs to relatives.
12. He threatened to arrest members for speaking out at the few meetings which were held.
13. He has failed and refused to fill vacancies in the precinct leadership to the extent that there are only 89 precinct positions filed and 109 vacancies.
14. He refused to help organize the 2014 Dayton Bellevue Memorial Parade.
15. He failed to organize any fund raising efforts for 2013 or 2014.
16. He failed and refused to give access to the e-mail list of regular members claiming his e-mail did not work.
17. He filled the vacancy of treasure without calling for a vote of the county committee.
18. His lack of respectability and leadership was demonstrated when the two local FOP organizations gave him a vote of no confidence for lying about his qualifications to be sheriff.

19. Refused to allow the formation of a Women's Group to do fund raising for candidates.

20. As a leader he has failed to address ongoing concerns of fellow Republicans creating a great divide amongst Campbell County Republicans.
